ALL APPLICANTS ARE REQUIRED TO COMPLETE AN AFFADAVIT AND SUBMIT WITH PERMIT APPLICATIONS.

YOU ARE REQUIRED TO SUBMIT AN AFFADAVIT FOR THE FOLLOWING:

1. That the load to be moved is **sixteen feet high or higher**, measured from the road surface to the highest part of the load away from the road surface.
2. That pursuant to **Nebraska Revised Statute 60-6,298(2)**, you will contact any and all electric utilities that have high voltage conductors and infrastructure that cross over the roadway affected by the move and made arrangements with such electric utilities for the safe movement of the load under any high voltage conductors owned by such electric utilities.
3. Please complete application for permit and submit completed affidavit as required. Electronic or printed signature is not accepted.

SINGLE TRIP PERMIT

PERMISSION FOR THE ABOVE MOVEMENT GRANTED TO

Subject to special provisions below of the permit and subject to revocation upon non-compliance. Movement to be made during daylight hours (sunrise to sunset) on any day except from Saturday after 1:00 p.m., unless otherwise stated on the permit, Sunday, or legal holidays and 1:00p.m. the day before a legal holiday, subject to good weather and road conditions unless specifically indicated below.

PERMIT NOT VALID DURING SNOWSTORM, BLOWING SNOW OR WHEN ROAD SURFACES ARE ICY OR SNOW PACKED OR WIND VELOCITY EXCEEDS 25 MILES PER HOUR IN VICINITY OF MOVE.

Special provisions pertaining to over dimensional mobile or modular housing permits:

MOVEMENT TO BEGIN ON

ROUTE:

Minimum speed shall be 35 miles per hour or as posted, except when road conditions or traffic are such that minimum speed cannot be safely maintained.

No escort vehicle or flagman shall be required on any County Highway unless specifically stated in OTHER PROVISIONS. If escort vehicle or flagman required the vehicle must carry "caution wide loads" sign, and have red flags 16 inches located on each of the extreme front corners of such vehicle. Escort vehicle driver shall be at least 18 years of age.

Red Warning flags not less than 16 inches square shall be displayed on all four corners of an over width cabin trailer.

All appurtenances extending beyond the actual width of Trailer to be moved.
